



What research degree programs can I study with the UniSA Business School?

Doctor of Philosophy (PhD):

The PhD program is aimed at candidates who have demonstrated academic research capabilities. The program is 4 years (full-time), examination is by thesis and oral video defence. As part of the research training students are required to participate in development and training activities including attendance at workshops and seminars. Research can be undertaken in any of the Business School's key research areas provided there is qualified and available supervision.

Masters by Research:

The Masters by Research program is aimed at candidates who may not have a research background but are interested in undertaking research. The program is 2 years (full-time), examination is by thesis. As part of the research training students are required to participate in development and training activities including attendance at workshops and seminars. Research can be undertaken in any of the Business School's key research areas provided there is qualified and available supervision.

The Masters by Research program is a pathway to the PhD program.

Am I eligible for a research degree?

Applicants for a research degree program must meet the minimum entry criteria prior to submitting an application. International applicants must also meet the English language requirements and upload documentary evidence with your application as to how you meet the minimum criteria.

Entry criteria – Masters by Research

You need to have successfully completed either a:

- 3 year Bachelor degree with a credit average; or
- Honours degree (1, 2 or 3); or
- Masters by Coursework

At least one of the degrees must be in a discipline relevant to your intended field of research.

Entry Criteria - PhD

You need to have successfully completed either a:

- Bachelor degree plus an Honours degree (1 or 2A); or
- Masters by Research; or
- Masters by Coursework with a significant research component; or
- undergraduate or postgraduate coursework degree PLUS significant work experience and at least 2 quality academic publications.

At least one of the degrees must be in a discipline relevant to your intended field of research.

Do I need a supervisor prior to submitting an application?

In your online application you will be asked to nominate a supervisor - however in the Business School you do not need to seek approval from a supervisor before you apply. Please see below further information regarding nominating a supervisor according to the relevant school's preference.

Please refer to the specific requirements with regards to your proposed research area as follows:

Commerce and Law: If your proposed research area is in the field of commerce or law, it is preferred that you nominate a supervisor you would be interested in having as your supervisor, but it is not mandatory. You can search for potential supervisors in our Directory of Research Expertise (DORE): <http://w3.unisa.edu.au/research/expertise/default.asp> or contact the relevant Research Education Portfolio Leader in the School of Commerce or the School of Law to discuss potential supervision.

Management: If your proposed research area is in the field of management it is mandatory to upload a document to your application nominating 1-4 academics who you would be interested in having as your supervisor. You do not need to contact your nominated supervisors to seek approval. It is a nomination only and this information will be considered during the assessment process and if there is supervision available in your research area, the School of Management will appoint a supervisory team on your behalf.

Marketing: If your proposed research area is in the field of marketing, you should contact the School of Marketing and the school will work with you to identify the best project and supervisory team to suit your skills and interests before you apply.

Where can I find information about scholarships and closing dates?

University-wide research degree scholarships are available to help finance your degree. Scholarship allocation is a highly competitive process, based on academic merit and area of research. Students will generally commence in the research degree program in February of the following year. Applicants must indicate in their online application for admission if they want to apply for a university-wide scholarship.

International applicants in the research area of management: Last application date for admission and/or university-wide scholarship – 10 August.

International applicants in the research area of commerce, law and marketing: Last application date for admission and/or university-wide scholarship – 31 August.

Domestic applicants in the research area of management: Last application date for admission and/or university-wide scholarship – 10 October.

Domestic applicants in the research area of commerce, law and marketing: Last application date for admission and/or university-wide scholarship – 31 October.

If I am currently undertaking an undergraduate or postgraduate degree - can I apply for a research degree program before I have completed my current degree?

Yes, you can apply for a research degree program before you complete your current degree, however you are not permitted to be enrolled in the program until your degree has been conferred. If your application is successful, you would receive an offer of admission that is conditional on the successful completion of your current degree.

How do I apply for a research degree?

Applications are made through Apply Online, our secure online service. When you are ready to submit an application through Apply Online, you will need to provide details about your proposed research including the proposed research outline, your academic qualifications, professional experience, academic referee reports and any scholarship you may wish to apply for.

What are the tuition fees for a research degree?

Domestic students:

Under the Australian Government's Research Training Program (RTP), Australian research degree students are exempt from tuition fees for the approved degree duration. Students who exceed these times are liable to pay tuition fees.

- PhD students are exempt from tuition fees for up to the equivalent of 4 years full time;
- Masters by Research students are exempt from tuition fees for up to the equivalent of 2 years full time.

International students:

Annual program fees are AU\$32,700 for 2018.

How long does it take to receive an offer of admission and/or scholarship?

It generally takes about **6-8 weeks** after the closing date of applications for applicants to receive an offer of admission and/or scholarship, or notification in the event that the application was not successful.

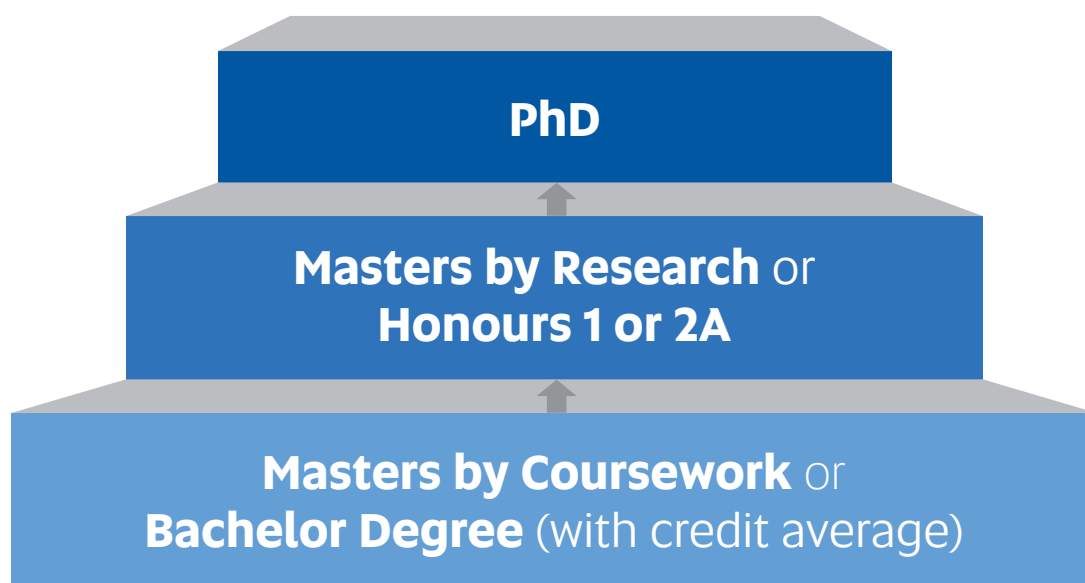
